MEMORANDUM OF UNDERSTANDING BETWEEN GOVERNMENT COLLEGE OF EDUCATION JAMMU, JAMMU AND INDIAN POLLUTION CONTROL ASSOCIATION ON WASTE MANAGEMENT IN THEIR CAMPUS

1. Background

The Indian Pollution Control Association (IPCA) and Jammu share a common goal of making the Jammu Province, Clean and improve the quality of life for its citizens. IPCA has more than 20 years of experience of working with different communities on waste management related issues, while Government College of Education Jammu has its systems on ground to deliver basic services to its citizens. Specifically, drain cleaning, manage solid waste, parks and playgrounds, provide primary education and health services.

Government College of Education Jammu under the Swachh Bharat Mission (SBM) is also committed to provide waste management facilities in their campus.Government College of Education Jammu is facing many challenges to provide this services in its area.

Towards achieving its goals including under the SBM, Government College of Education Jammuseeks to undertake a series of awareness campaigns for students and staff memberscapacity building and behavior change.

IPCA for over last Twenty years, has worked on various projects of solid waste management including door-to-door collection of waste, awareness on source segregation, strengthen secondary segregation through capacity building of waste pickers community, establish network of recyclers to increase rate of waste recycling. IPCA has developed self sustainable model of waste management and replicated the same with other parts of country with its associate partners.

This Memorandum of Understanding (MOU) establishes a **non-financial partnership** between Government College of Education Jammu and IPCA (referred as partners hereon) for each partner to share their respective strength in order to achieve the following objectives.

2. Objectives

The objective of this partnership will be to:

2.1 Bring sense of responsibility among the students for their waste management.
2.2 Bring about behavior change and awareness among the students on issues of waste management, particularly zero littering, segregation, waste collection.
2.3 Put appropriate efforts for plastic waste management in Jammu, which include collection of non-recyclable plastic waste and channelize plastic waste to waste to energy plant.

IPCA under this MOU withGovernment College of Education Jammu shall do the following work, but not limited to:

- 1. Create awareness on plastic waste management with all stakeholders.
- 2. Demonstrate a broad range of options and strategies to optimize available resources.
- 3. Collect Dry waste on date decided by the College Administration.
- 4. Facilitate knowledge sharing, capacity building and training sessions of students, Government College of Education Jammu staff and all stakeholders involved in Solid Waste Management.
- 5. Will run "My 10 kg Plastic " campaign to provide end of life solution for collected Plastic.
- Channelize the plastic waste to waste to energy plant for end of life solution to the waste and for its energy recovery.

Government College of Education Jammu shall undertake to do the following:

- 1. Extend support to IPCA in delivering the above tasks.
- Providing the data and necessary information to develop the PWM Plan, if available.
- 3. Facilitate introductory meetings with the staff, students and other stakeholders.
- 4. Provide necessary document/certificate, which would state the receiving and processing of plastic waste delivered by IPCA to the waste to energy plant.

3. Monetary Support

IPCA shall not seek any monetary support from Government College of Education Jammu in the implementation, and shall arrange its own resources. Government College of Education JammuJammu would however may provide Information, Education, and Communication material to IPCA for the dissemination of required knowledge and information about the plastic waste management in the community.

4. Implementation

IPCA and Government College of Education JammuJammu agrees to set-up a Steering Committee under the assigned representative of Government College of Education Jammu.

IPCA's representative would update the undersign or Government College of Education JammuJammu authorized representative about the activities undertaken through this MOU and would take their feedback and suggestions to meet the above mentioned objective in more meaningful manner.

5. General Provisions

- 1. The participants enter into this MOU while wishing to maintain their own separate and unique missions and mandates, and their own accountabilities. Unless specifically provided otherwise, the cooperation among the Participants as outlined in this MOU shall not be construed as a legal entity or personality. Each Party shall accept full and sole responsibility for any and all expenses incurred by itself relating to this MOU. Nothing in this MOU shall be construed as an exclusive working relationship. The Participants specifically acknowledge that this MOU is not an obligation of funds, nor does it constitute a legally binding commitment by any Parties or create any rights in any third parties.
 - 2. Nothing in this MOU shall be construed as interfering in any way with any separate agreements or contracts entered into by or among the Participants in their individual capacities either prior or subsequent to the signing of this MOU.
 - 3. This MOU becomes effective on the date of its signature by the Participants and shall remain valid until 31st March 2024. However, the Participants may decide in writing prior to its expiry to extend this period. In addition, this MOU may be modified or amended if the Participants agree in writing. Either participant may terminate this MOU at any time after giving the other Participant at least 30 days' advance written notice.

Further agreements concerning any program shall provide details concerning the specific commitments made by each party and shall not become effective until they have-been reduced to writing, executed by the duly authorized representatives of the parties.

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is made on this 97... day of November, 2021 at Jammu.

BETWEEN

Govt. College of Education, Jammu through its principal presently Prof. (Dr.) Kulwinder Kaur

Party of the first part.

AND

Govt. Ayurvedic Hospital, Jammu Jammu and Kashmir, through its Medical-Superintendent, presently Dr. Vandana Dogra, *Party of the Second Part.*

The expression party of the first part and party of the second part shall however mean and include their successor organizations, appointees, assignees, etc.

WHEREAS, Government College of Education Jammu is a constituent college of Cluster University of Jammu, a Government Organization in Jammu & Kashmir under the Department of Higher Education. It is a NAAC Accredited 'A' Grade and center of excellence for providing high quality teaching skill training to teachers in Jammu Division of J&K.

WHEREAS, the Govt. Ayurvedic Hospital, Jammu under the aegis of Directorate of Ayush, Jammu and Kashmir, Department of Health and Medical Education. Government of Jammu & Kashmir is an organization responsible for promotion and development of Ayush sector i.e. traditional Indian systems of health care and providing tertiary level Ayush health care facilities to the public, along with the promotion of preventive and health preservation measures through public health outreach and IEC through Ayush principles and practices of self-health care and health education.

NOW IT IS HEREBY AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. That the Government College of Education Jammu will establish herbal garden (Arogya Vatika) and Nutritional Garden (Poshan Vatika) in the premises of Govt College Education, wherein the herbs with medicinal and nutritional potential shall be cultivated.
- 2. That the Govt. Ayurvedic Hospital, Jammu J&K will provide technical inputs and planting material, IEC material on various medicinal and nutritional plant species.
- 3. That the Govt. College of Education will arrange academic visit of students in batches at the model Demonstration Medicinal Garden cultivated at Directorate of Ayush J&K, Jammu. (Arogya vatika).
- 4. That the Govt. Ayurvedic Hospital, J&K will provide onsite demonstration and orientation lectures on various medicinal plant species and their health benefits to the visiting students and faculty.
- 5. That the Govt. College of Education will arrange demonstration Sessions on Yoga asana. Meditation and Yogic Kriya on weekly/ fortnightly basis and provide required space and material for the same.
- 6. That the Govt. Ayurvedic Hospital, J&K will depute experts for these demonstration and awareness sessions. Directorate of Ayush will also provide relevant IEC material for the same.
- 7. That the Govt. College of Education will organize awareness and demonstration lectures on Principles of *Dincharya*. *Ritucharya*. *Sadvruta*, which will be delivered by experts from GAH and optimal nutrition for promotion of school health in accordance with the principles and practices of Ayush systems for integration into the educational curriculum.
- 8. That the Govt. Ayurvedic Hospital, Jammu will depute experts for these demonstration and awareness lectures as per the demand of the Govt. college of Education. Directorate of Ayush will also provide IEC material for the same.
- 9. That the Govt. College of Education will organize for Health Check-up cum Health themed awareness camps every two months i.e. six camps in a year.
- 10. That the Govt. Ayurvedic Hospital Jammu, J&K will also depute team of expert doctors and paramedical staff and provide Ayush medicines, Immunity booster kits and Poshan Kits along with relevant IEC material.

- 11. That Govt. College of Education, Jammu and Govt. Ayurvedic Hospital Jammu will constitute a joint research team to study the effects of Yogic and Ayush interventions on various cognitive, emotional and behavioural patterns of students and teachers. Joint team will also study the social impact of Yoga and Ayush Interventions in schools, colleges associated with Govt. College of Education. Govt. College of Education will also provide their research facilities for the joint research activities.
- 12. That the Govt. College of Education, Jammu and Govt. Ayurvedic Hospital Jammu will jointly contribute chapters on "Health Through Ayush Interventions" for integration of Ayush in the educational curriculum i.e. into the textbooks of JKBOSE. Jammu University so that Ayush can be taught in Schools and Colleges especially in the domain of Health Education.
- 13. That the Govt. College of Education, Jammu and Govt. Ayurvedic Hospital Jammu will jointly design a 6 month add on course for "Health Education through Ayush for Healthy Teachers and Healthy Schools." Both the parties will make active efforts for the recognition of the course from University of Jammu and jointly contribute in terms of running the course successfully.
- 14. That the Govt. College of Education, Jammu and Govt. Ayurvedic Hospital Jammu shall also engage meaningfully in developing the literature of Health Education through Ayush Interventions, designing of IEC material for children and general public, through collaborative teams, so that the joint literary works can be published and show cased as best practices.
- 15. That this MoU and the financial assistance given to pursue the MoU shall not be deemed to have created any association, partnership, etc. and financial assistance involved, if any, is not refundable.
- 16. That this MoU will be operative from the date of signing by both the parties and shall be for a period of 1 year from the date of signing by both the parties. The tenure of the same can be further extended by mutual consent of both the parties.
- 17. The Parties agree that any dispute or difference arising out of or in connection herewith or anything done or omitted to be done pursuant hereto shall be attempted to be first settled amicably by the committee constituted for the purpose failing which, it shall be referred to Administrative Department of Health & Medical Education, and Administrative Department of Higher Education and the joint decision of Administrative Departments shall be final and binding on both the parties.
