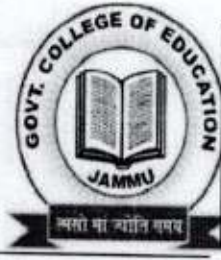

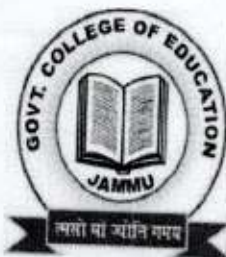

Report on Admission of 1st Batch Four Year Integrated Teacher Education Programme (ITEP) at Government College of Education, Jammu

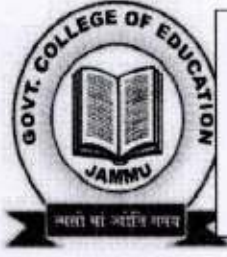
Constituting of ITEP Admission Committee

1. The ITEP Admission Committee was framed appointing Prof. Anuradha Choudhary as Convener and Dr. Rakesh Bharti as Co-convener.
2. The admission process started on 06-09-2024.
3. Dean Academic Affairs, Cluster University of Jammu and 09.11.2023 (All Deans with VC, Cluster University of Jammu) to finalize course and fee structure of ITEP
4. The 5th Academic Council Meeting of Cluster University of Jammu, chaired by the Hon'ble VC on 17.11.2023, granted unanimous approval for ITEP admissions.
5. After receiving list of students for ITEP by NTA, the college started the admission process in the campus.
6. After scrutiny of final admissions a total number of 16 students were admitted in the first batch of ITEP.
7. Frequent meeting were conducted with Dean Academic Affairs, Cluster University of Jammu for finalization and adoption of curriculum ITEP BA B.Ed. Preparatory stage.

Current Status and Future Prospects

1. Despite initial setbacks, the inaugural batch of ITEP is successfully progressing with 16 students in the first batch under the academic session 2024-25 with 2 students from Bihar thus adding diversity.
2. The commitment to the effective implementation of ITEP continues, ensuring alignment with the National Education Policy (NEP) 2020 and maintaining high academic standards.

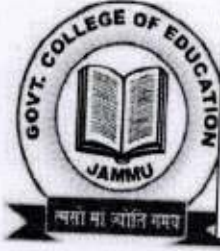

This was followed by discussion over the following points:

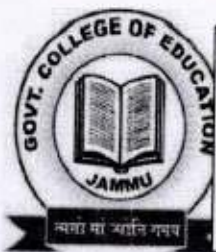

Introduction

The implementation of the Integrated Teacher Education Programme (ITEP) at Government College of Education, Canal Road, Jammu, has been a transformative journey marked by dedication, perseverance and institutional collaboration. This report records the significant milestones, challenges and achievements of the ITEP initiative.

Background

The National Council for Teacher Education (NCTE), Delhi, invited applications for the academic session 2023-24 to launch the 4-Year Integrated Teacher Education Programme (ITEP) on a pilot basis. This call was open to Central and State Government institutions as per public notice No: F.No. NCTE-Reg1022/14/2021-Reg. Sec-HQ Dated: 01.05.2022.

Application and Scrutiny Process

1. Govt. College of Education, Canal Road, Jammu, applied for approval to NCTE on 30.05.2022 via application number 2324202205251153.
2. NCTE issued a show-cause notice (SCN) seeking documentary proof of institutional status, government recommendations, and earmarked built-up area.
3. After submitting the required clarifications, a virtual inspection of the campus was conducted on 01.12.2022.
4. A second SCN was issued regarding fire and building safety, including provisions for a specialized toilet for physically challenged persons. The college administration, with the support of Cluster University of Jammu, addressed these concerns.
5. Following compliance, NCTE issued a Letter of Intent (LoI) on 30.01.2023, requiring faculty appointments within 60 days.
6. Upon fulfilling LoI requirements, NCTE granted recognition for 12 units of B.A. B.Ed, B.Sc. B.Ed, and B.Com. B.Ed for Foundational, Preparatory, Middle, and Secondary

stages (Order No. F.No. NCTE/NRC/2324202205251153/Jammu and Kashmir/2022/Recognition Dated 03.03.2023).

Implementation and Initial Challenges

1. The recognition was communicated to the Administrative Department, JKHED, and Cluster University of Jammu, leading to the formation of an Advisory Committee by the Hon`ble VC, Cluster University of Jammu.
2. Based on the Advisory Committee's recommendations, it was resolved to start one unit each for B.A. B.Ed (Foundational Stage) and B.A. B.Ed (Preparatory Stage).
3. The NRC, in its 398th and 40th meetings (09-10 May 2023 and 09 June 2023), granted recognition for one unit each of B.A. B.Ed for Foundational and Preparatory stages while withdrawing other units for the 2023-24 session (Order No. F.NCTE-Regl011/25/2023-Regulation Section-NRC/222343 Dated: 07.07.2023).

Awareness and Sensitization Initiatives

On 27.10.2023, the Department of Educational Studies, Central University of Jammu, in collaboration with NCTE, organized an 'Information Sharing Session for Sensitization on ITEP aligned with NEP 2020.' Key attendees included:

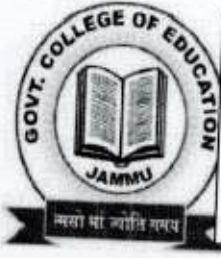
