It shall be presumed that the candidate has gone through the information contained in the Information Brochure and has agreed to follow the conditions contained therein. No candidate can claim any alteration in the conditions which have been incorporated in the Information Brochure and notified in advance.*

- (iii) *Subject to availability of logistics, the Board may consider Online Examination, if so decided by the Board otherwise the examination shall be conducted in the Offline Mode.*

## 1. INTRODUCTION:

The Jammu and Kashmir Board of Professional Entrance Examinations (BOPEE) was established by an Act of State Legislature (Act No.XXV of 2002). It is the responsibility of the Board to recommend selection of candidates for admission to various Professional Courses at Undergraduate/Postgraduate levels in the various Government run and privately managed institutions in the UT of J&K. These programmes, inter-alia, include B. Ed. Course, as well.

The recommendations for admission to B.Ed. is made purely on the basis of merit obtained in the Entrance Test,if conducted by the Board, otherwise on the basis of marks secured by candidates in the Graduation.

The e-information Brochure gives a fair idea about the procedural details of the Entrance Test to the aspiring candidates. The most crucial step is the filling up of the Application Form. The selection is made according to the information furnished by the applicants in their Application Form and merit secured in the Entrance Test, if conducted by the Board, otherwise on the basis of marks secured by candidates in the Graduation.

The candidates must, therefore, carefully go through the e-information Brochure before filling up their Application Forms. Any mistake/error at the initial stage shall not be rectifiable later on. This may prove detrimental to the aspiring candidates.

## 2. TERMS AND EXPRESSIONS:

Certain terms and expressions, used in the e-information Brochure have specific importance unless, of course, the context otherwise denotes. For the benefit of the candidates, these terms and expressions are briefly defined herein under:-

- ❖ **Act:** means J&K BOPEE Act, 2002.
- ❖ **Advertisement Notice:** means the notification issued by the J&K Board of Professional Entrance Examinations(BOPEE) inviting applications from eligible candidates for appearing in the Entrance Test;
- ❖ **Common Application Form:** means the Form prescribed by the BOPEE to be submitted online by the eligible candidates for appearing in the Entrance Test;
- ❖ **Available Seats:** means the seats against which admissions to B. Ed (Bachelor of Education) Course are ordered by the Government/notified by other Govt. Departments/Agencies;
- ❖ **Eligible Candidate:** means the candidate who fulfills the requirements of eligibility as prescribed by the BOPEE and the UT of J&K/ Ladakh from time to time;
- ❖ **Entrance Test:** means the test held by the BOPEE for making selection of eligible applicants for admission to B. Ed. (Bachelor of Education) Course in the Government College of Education (IASE), Srinagar (under Cluster University of Srinagar), Govt. College of Education, Canal Road, Jammu (under Cluster University of Jammu) and Composite Regional Centre (CRC) in accordance with the UT of J&K guidelines;
- ❖ **Incomplete Form:** means the online Application Form which is wrongly filled in or contains false information of any kind or not having required and /or valid certificates or has any other deficiency and discrepancy whatsoever;
- ❖ **Merit List:** means list of candidates who appear in the Entrance Test/percentage of marks obtained in qualifying examination drawn up in the descending order of merit;
- ❖ **Qualifying Examination:** means the result of examination on the basis of which candidates become eligible to appear in the Entrance Test;
- ❖ **Regulations:** means the Jammu and Kashmir Board of Professional Entrance Examination Regulations, 2016,

- ❖ **Rules:** mean the Jammu and Kashmir Board of Professional Entrance Examination Rules, 2014.

### **3. GENERAL INFORMATION & INSTRUCTIONS:**

It is expected that the candidates shall be sincere, honest and behave responsibly while appearing in the Entrance Examination and shall not resort to any unfair/fraudulent means or impersonation in the examination. In case, a candidate is found resorting to unfair means, criminal proceedings under rules shall be initiated against him/her including his/her abettors/facilitators, besides debarring him/her for such a period as may be decided by the Board in accordance with rules and regulations of the Board, from appearing in the Entrance Test in future.

- ❖ The candidates interested in appearing in the B.Ed. Entrance Test are required to:
  - Go through e-Information Brochure carefully and acquaint themselves with all the requirements;
  - Satisfy the prescribed eligibility conditions; and
  - Submit online Application Form within the prescribed date.
- ❖ The candidates applying for admission, will be required to appear in the Entrance Test at their own expenses at the Centres fixed by the Board, if conducted by the Board;
- ❖ The recommendation for selection of the candidates in all the categories shall be subjected to production of all the relevant certificates in original by the candidates and the genuineness of the same by the College/university;
- ❖ The Board can verify the original documents at any stage of counselling/admission process. If the original and valid documents are not found as per the prescribed eligibility, the candidature can be cancelled at any stage of admission;
- ❖ No intimation, whatsoever, about non-selection will be sent individually and no correspondence in this regard shall be entertained. The result will also be available on BOPEE website: [www.jkbopee.gov.in](http://www.jkbopee.gov.in);
- ❖ The selections made by the BOPEE to the Professional Courses shall be provisional till final determination of eligibility of the candidates to be decided by UT of J&K or UT of Ladakh by the concerned University/ College;
- ❖ **The BOPEE shall have powers to review the provisional selection list at any time, notwithstanding the fact that the selected candidate has completed his/her admission formalities, where any bonafide error, lapse, mistake, fraud, cheating, misrepresentation, misinterpretation, impersonation or glaring injustice comes to its knowledge or is brought to its notice which has resulted in the inclusion of the candidate in the selection list. Mere selection in the list does not confer any right to admission of the candidate, if he/she is otherwise found ineligible;**
- ❖ **Complaints against certificates, including those of reserved categories, will not be entertained as the BOPEE is neither an appellate authority nor an investigating agency;**
- ❖ Permission of candidates to appear in Entrance Test shall be provisional on the basis of the entries in the Application Form, subject to their eligibility prescribed for the course;
- ❖ **The Answer Key will be displayed on the BOPEE website in the evening before 6 P.M. on conclusion of the Test or up to 12 Noon next day and will remain there for three days (03) and thereafter will be removed. The candidates, who have any complaint against an answer of a question in the Question Paper are free to make written representation supported by documentary proof of standard text Books on the prescribed format available on the official website of BOPEE and in the BOPEE office at Srinagar/Jammu, which should reach in the office (Srinagar/ Jammu) within three working days after the Key is made available and thereafter no representation will be entertained/accepted. They shall have to pay a fee of Rs. 1000/- paid at POS Terminal at BOPEE Office Srinagar/Jammu in this behalf;**
- ❖ The Answer Key will be got re-examined by the BOPEE on the basis of the representations so received and the Revised Key, if any, will be final and no complaint will then be entertained regarding the Revised Key. After satisfying, the revised Key will be uploaded on the website of the

BOPEE. The revised Answer Key, if any, will be applied to Answer Sheets of all the candidates, no matter whether they have made such representations or not;

- ❖ OMR Answer Sheets of candidates are Machine Graded and Scanned / scrutinized and double checked with extreme care. As such, there shall be no re-evaluation/ rechecking of OMR Answer Sheets. No correspondence in this regard shall be entertained by the Board;
- ❖ Re-totalling of marks will be allowed on written request along with payment of Rs. 1000/- fee paid at the POS terminal at BOPEE office Srinagar/Jammu. The application will be received within 03 days after the declaration of result. Any application received after the stipulated time will not be entertained.

### Instruction for Photographs

Candidates must also follow the following instructions:

- Please ensure that the photograph is taken in a light colored background;
- The photograph/signature/thumb-impression images to be uploaded in JPG/JPEG format only;
- The maximum size of the photograph should be within the range of 10-50 KB and for signature/thumb-impression within the range of 10-50 KB;
- Photographs, with name of the candidate must be snapped on or after 01-01-2026;
- The photograph must be snapped with a placard indicating name of candidate and date of taking photograph. In case name and date are written on the photograph after taking it, the application is liable to be rejected;
- The name and date on the photograph must be clear and legible,

- Photograph should be without a cap and goggles. However, spectacles are allowed.

### **Warning:**

- a) The Candidates are warned not to resort to any unfair/fraudulent means or act of impersonation at the time of Entrance Test or upload any objectionable material including a photo of any object, other than his/her own photograph while submitting the online form. In case, a candidate is found taking recourse to such acts, criminal prosecution shall be initiated against him/her and his/her abettors. He /she shall be permanently debarred from appearing in the Entrance Test in future.
- b) Any candidate uploading image of an object other than his/her own photograph shall be disqualified from appearing in the Examination(s). Besides action as warranted under law shall also be taken against such candidate.

### **4. DURATION OF COURSE:**

The duration of the Bachelor of Education (B.Ed.) Programme shall be Two Academic Years or as per norms of the affiliating University.

## 5. ELIGIBILITY:

- ❖ A candidate applying for the Entrance Test for admission to the B. Ed. Course must:
- have Domicile Certificate of UT of J&K /UT of Ladakh. **Candidates belonging to UT of Ladakh, ST certificate issued by Competent authority of Ladakh shall be treated as Domicile certificate;**
- have passed with at least 50% marks either in the Bachelor's Degree and/or in the Master's Degree in Sciences/Social Sciences/Humanity, Bachelor's in Engineering or Technology with specialization in Science and Mathematics with 55% marks or any other qualification equivalent thereto, are eligible for admission to the program and 5% relaxation for reserved categories such as SC/ST-I/ST-II/OBC/ALC/IB/RBA;
- The candidates appearing/appeared in the qualifying examinations are also eligible to apply and appear in the Entrance Test but they have to upload/submit the qualifying examination certificate within the prescribed date to be notified separately. Further, such candidates must have to pass their qualifying examination as per the above eligibility on or before the issuance of Provisional Selection List, otherwise their candidature shall and shall be deemed to have been cancelled without any notice *abinitio*.

### NOTE:

The eligibility is bare minimum/provisional and shall be subjected to such changes/bench marks as may be fixed by the affiliating university/agency. The Board shall on receipt of any such communication from the concerned authority/Council notify the same, which shall govern the eligibility criteria.

## 6. RESERVATION POLICY:

- ❖ A candidate seeking admission under a Reserved Category as specified under S.O176 dated 15-03-2024 read with S.O 305 dated 21-05-2024 or as amended from time to time by UT Govt. of J&K, is required to upload self-attested copy of the relevant certificate issued by the designated authority alongwith the Online Application Form (**Annexures-I**).
- ❖ A candidate claiming benefit under Sports Category must have to mention his/her Sports Category in the Online Application Form and must submit copies of these certificates in the office of the Secretary, J&K Sports Council for Sports Points well before the date fixed by the J&K Sports Council. For the purpose of determining the merit of sports category candidates; 60% and 40% weight-age shall be given to the merit obtained in the Entrance Test & Sports Points respectively.

The following reservation Policy shall be implemented as per S.O176 dated 15-03-2024 read with S.O 305 dated 21-05-2024 of seats in the Government Colleges / Institutes:

- ❖ **4 % seats shall be reserved for candidates belonging to UT of Ladakh in each Govt. Colleges.**

**Note:**

- 1) The seats under EWS category in IASE, M.A. Road Srinagar, if any, approved by the Competent Authority shall be notified separately in the seat matrix.
  - 2) The category Certificates should be on the prescribed format and duly renewed whenever required under rules.
- ❖ Rules 5 and 6 of the JK BOPEE Rules, 2014 deal with reservation of candidates for admission to various Professional Courses. These two rules have been reproduced verbatim hereinafter for the benefit of the candidates. They are advised to go through these Rules before they attempt to fill up their Online Application Form.
  - ❖ **Rule 5: Reservation for candidates for admission to various Professional Courses:**
    - The reservation of admissions shall be applicable only in the Government-run Colleges as notified by the Government from time to time;
    - The percentage of seats to be allotted under each category shall be such as notified by the Government from time to time;
    - The benefit of reservation shall be available to the concerned candidate only if the valid Category Certificate is uploaded with the Application Form as **mentioned in the online Application Form at the time of its submission before the expiry of the last date;**
    - **Where a Category Certificate has not been issued by the designated authority, the candidate shall not be given an opportunity to validate it after the expiry of the last date for submission of the Application Form;**
    - **No notice shall be given to a candidate whose category certificate has been found invalid by the BOPEE and such a candidate shall be considered in Open Merit, if found otherwise eligible;**
    - **The category certificate issued after the expiry of the last date shall in no case be accepted;**
    - No “under process” certificate shall be accepted/ entertained at any cost. It includes “under process” certificate for the renewal of category certificate;
    - **The category certificate must be valid at the time of submission of online Application Form;**
    - If a candidate fails to submit/upload reserved category certificate during the filling up of Online Application Form, his/her application will be considered under Open Merit Category, if otherwise found eligible;

- A candidate can apply/opt for one Reserved Category only and choice regarding reserved category once exercised shall be final and at no stage, shall be allowed to be changed;
- A candidate will be considered only for one Reserved Category for selection against the seats reserved for that category for which he/she has mentioned in the online Application Form even if he/she is eligible to be considered for seats available in more than one category,

❖ **Rule 6: Competent authority:**

- Authorities competent for issuing reserved category certificates shall be such as notified by the Government from time to time:  
Provided that in the case of Children of Defense Personnel other than core service, a candidate having a certificate that his/her father is working in Defense Establishment (Military Engineering Service or other service of like nature) where salary is paid out from Defense Estimates is not entitled to the benefit of CDP Category;
- Where this certificate is wrongly accepted and the candidate gets admission on the basis of this certificate, the admission of such candidate will be cancelled forthwith as and when such error comes to the knowledge of the BOPEE or is brought to its notice;  
Provided further that the candidates having “Outstanding Proficiency in Sports” must also submit their certificates to the Secretary, J&K Sports Council for awarding points which will then, be officially forwarded to the BOPEE by the J&K Sports Council. The BOPEE shall not be responsible where a candidate fails to submit certificates to the Council or Council fails to forward the points of a candidate to the BOPEE. It shall be the sole responsibility of the candidate to ensure that his/her Sports Points are forwarded by the Council to the BOPEE in time;
- The Children of serving BSF, CRPF, ITBP and CISF do not fall under CDP category but fall under the category of JKPM. The candidates claiming benefit of any of these categories must ensure and understand properly under which category they fall and should accordingly enter the Category Code;
- The category candidates should ensure that their Reserved Category Certificate is issued by the designated Competent Authority and is uploaded with the online Application Form strictly in accordance with the Guidelines given in the e-information Brochure. All the Category Certificates issued/dated after October, 2005 **must be issued under SRO 294 of 2005, SRO 518 of 2019 and S.O176 dated 15-03-2024 read with S.O 305 dated 21-05-2024**. The certificates issued under earlier SRO will be accepted only if they are dated prior to October, 2005. However, this shall not apply to SC/ST candidates in whose case certificate has been issued prior to the issuances of SRO 294 by the Competent Authority. **The candidates should insist on the certificate issuing authority to make mention of SRO 294 in their certificates if they are issued after October, 2005;**
- **The certificate issued after the “last date for submission of Application Form is over” will not be entertained.**

**7. FEE Structure (Tentative):**

The fee to be paid by the candidate to the concerned college is not fixed by the BOPEE. The eligible candidate(s) are advised to verify fee from concerned College/Institution on their own before applying for these courses. Hence, no complaint in this regard will be entertained by the BOPEE.

## 8. COMMON APPLICATION FORM (CAF):

- ❖ The Application Forms have to be **submitted online only** through the BOPEE websites [www.jkbopee.gov.in](http://www.jkbopee.gov.in) (through URL's/ links provided for this purpose) within the prescribed date to be notified separately. The payment of rupees 1200 (Rupees one thousand and two hundred only) as fee is to be made online through "Integrated Payment Gateway" with the help of any National Credit Card/Debit Card facility. The procedure for filling in the Application Form and eligibility etc of the candidates has been given in detail in this e-information Brochure. The candidates must necessarily, in their own interest, go through this e-information Brochure before attempting to fill up the online Application Form;
- ❖ The applicants are advised to fill the online Application Forms on their own or through a responsible person. The applicants can also contact the "Help Desk" of I.T. Section of the BOPEE on 0194-2437647, 0194-2433590, 0191-2479371, 0191-2470102, for any assistance/guidance/filling of online application form in this regard on any working day, during office hours only, within the prescribed last date. The Reserved Category Candidates have to upload their Category Certificate alongwith the Online Application Form;
- ❖ The candidates can change/ modify their online Application Form at any time before its submission as prescribed in the Notification. It is in the interest of the candidate to recheck before submitting the online Application Form. They are advised, in their own interest, not to share their login details with anybody, lest he/she may get an opportunity to change important details in the Application Form. They can check the status of their Application Form on the official website of the BOPEE. If any form is not approved or remained deficient for want of required information pending of any document, if any, the candidate concerned must report in the BOPEE office by or before the stipulated date fixed for this purpose in the Admission Notification, failing which his/her Application Form shall be rejected;

- ❖ A candidate will be considered for only one reserved category for selection even if he/she has more than one reserved category and the category that will be considered will be the one selected

by the candidate in Common Application Form. For example, if an applicant is a ward of a Police Personnel, and also hails from a Backward Area and belongs to Scheduled Caste too and he/she selected Scheduled Caste Code. at the relevant Serial No. of the Application Form, the candidate shall be considered for selection against the available seat for Scheduled Caste category only and not any of his/her other category;

❖ **Time duration for the Entrance Examination shall be one hundred and Eighty (180) minutes (three hours).**

## 12. CONDUCT OF ENTRANCE EXAMINATIONS (shall be decided by the Board from time to time):

### ❖ Centres of Examination:

- The Entrance Examination shall be held at the centres as may be specified by the BOPEE either in Srinagar City/Jammu City or in both cities;
- Centres shall be allotted by the BOPEE and the information for the same shall be provided to the candidates on the Admit Card;
- The Centre of Examination once allotted shall not be changed,
- The BOPEE shall not conduct another test in any circumstances what so ever for those candidates who fail to appear in the Test on the scheduled date.

### ❖ Nature of Question Paper:

- It shall be the sole responsibility of the candidate to check the Question Booklet before attempting to answer any question. Where a Question Booklet has any missing/blank page, missed question or damaged or defaced page, it shall be the sole responsibility of the concerned candidate to bring it into the notice of the concerned Invigilator and get it replaced by a new booklet of the same series. The Question Booklet must have 180 Questions. No complaint in this regard shall be entertained by the Board after the conclusion of the examination;
- The question paper shall be Objective Type containing Multiple Choice Questions(MCQ's).It contains several pages stapled together in one cover. The questions are based on knowledge, understanding and application of the relevant subject that a Graduate student is expected to know in Entrance Test meant for admission to B. Ed. Course;
- Each Question Booklet is numbered. Before starting to answer the questions, please check the booklet thoroughly. In case of defects like missing questions, the book let shall be replaced with the same series by the Invigilator, whenever, reported. No complaint shall be entertained after the examination;
- Do not open the seal containing Question Booklet until you are asked to do so;
- Write your Roll Number on the Cover Page of the Question Booklet at the space provided for the purpose;
- Candidates should not make any type of marking on the Question Booklet. Paper for rough work is included in the Question Booklet,

- Each question paper has four series, which are in alphabets i.e.A, B,C,D printed on the cover page of the Question Booklet. At the end of the examination, candidates can take the Question Booklets with them.

❖ **Nature of OMR Answer Sheet:**

- In order to maintain transparency of examination, each candidate is provided (Optical Mark Reader Answer Sheet) having Original copy and Candidate's copy (**Annexure VI**). The candidates are directed to fold at perforation at the top of sheet, tear it after the examination is over and separate original copy and candidate's copy. Finally, they have to handover the original copy to the invigilator and take along with the candidate's copy;
- The OMR Sheets (Optical Mark Reader Answer Sheets) are used in order to simplify the procedure of evaluation of the Answer Sheets and also to ensure highest accuracy. Each circle on the OMR Sheet has an alphabetical or numerical values. So a small mistake in shading the round spot on the circle will not be scanned properly by the machine;
- The OMR Sheets will be supplied to the candidates in the Examination Hall;
- At the top of the OMR Sheet, there are few blanks which are to be filled in by the candidate very carefully;
- Write Question Booklet number, booklet series and Roll Number in numerals and in case of any difficulty, seek the assistance of the Invigilating Team;
- Write the given certification state mention your running handwriting in English and append your signature and Left Hand Thumb Impression at the space provided for the purpose on Sheet. This certificate is to be authenticated by the concerned Invigilator and Superintendent of the Examination Centre;
- Complete the formalities and wait for the signal to start, tear and open the seal, open Booklet, begin answering and answering the questions;
- Recording wrong Roll No. or Question paper series or its omission on response by darkening the appropriate circle completely with **black or blue ball point pen** on the answer in the OMR Answer Sheet shall be done by the candidate at his/her own risk. The Board shall, in no case, entertain any complaint of the candidate regarding this;
- Each question is followed by four responses i.e. 1,2, 3, and 4; of which only one is correct. Indicate the correct response by darkening the appropriate circle completely with black or blue ball point pen on the Answer Sheet,
- In case you do not follow the instructions given on the back side of Answer Sheet, your Answer Sheet is likely to be rejected whenever detected.

- No textual material, printed/handwritten will be allowed in the hall. Candidates are advised not to carry any such material in the examination hall;
- Candidates must report, in their own interest, in the Centre 45 minutes before the commencement of the examination. In no case a candidate shall be allowed to enter examination hall after the commencement of the examination;
- The candidate shall not be allowed to bring Calculators/Pocket Transistors/Electronic watches with facilities of calculator/slide rules, any form of table or any other such aid;
- Tea, Coffee, Cold Drinks or Snacks are not allowed in the examination hall during examination;
- Smoking in the examination hall is strictly prohibited;
- The candidate must sit only on the seat allotted to him/her;
- In no case a candidate can change his/her allotted seat;
- **No candidate will leave the hall before the expiry off fulltime duration prescribed fort he examination and without handing over Answer Sheet to the Invigilator on duty;**
- No person/persons other than those authorized by the BOPEE shall be allowed to enter the examination hall,
- The candidate's misbehavior in any manner in the examination hall shall entails his/her disqualification. Any disturbance in the examination hall shall be deemed as misbehavior and such candidate(s) shall forfeit the right to continue to sit in the examination hall. The decision of the Centre Superintendent shall be final in the matter.

#### 14. DETERMINATION OF MERIT:

- ❖ The merit lists shall be prepared on the basis of inter-se merit of the candidates in the Entrance Examination in the descending order for Open Merit Category and for each Reserved Category separately;
- ❖ The tie of the marks secured in the entrance test will be resolved in order of preference as follows:-
  - marks secured in **“Aptitude for Teaching Profession”**;
  - the candidate(s) older in age;
- ❖ The Board may fix such qualifying benchmarks for admission to the Course as may be deemed appropriate by the Board;
- ❖ In case of any subsequent vacancy/vacancies caused by whatsoever reason in any category, the same shall be filled from amongst the candidates belonging to that particular category strictly in accordance with the merit. In the event of non-availability of eligible category candidates under any Reserved Category, the unfilled vacancies shall go to the Open Merit Category.

#### 15. DECLARATION OF RESULT AND NOTIFICATION OF MERIT LIST(in case the entrance test shall be conducted by the Board):

- ❖ The Evaluation of the Answer Sheets is done mechanically so there is no chance of any mistake. The result declared by the machine shall be final and not open to any manual check. It has been noticed that some students make faint marks or ambiguous impressions or incomplete marks on the OMR Sheets which are scanned by the machine and the decision of the machine will be final and not subject to any manual check. It is, therefore, advised in the interest of the candidates to fill up OMR Sheet carefully and properly as shown in this e-information Brochure. The Re-evaluation of the Answer Sheets manually, therefore, or otherwise, is not allowed as that will impinge upon the Rule of Equality which calls for Uniform Treatment given to all the candidates. However, re-totaling of marks **will be allowed on written request along with payment receipt of Rs. 1000/- paid at the POS terminal at BOPEE office Srinagar/Jammu. The application will be received within 03 (three) days or days fixed by Board after the declaration of result. Any application received after this date shall not in any case be entertained.**
- ❖ Rule 13 of the JK BOPEE Rules, 2014 lays down the procedure relating to incorrect questions which is reproduced verbatim herein below for the benefit of the candidates.
 

**“13. Deletion of invalid questions and methodology in evaluating such questions:** If during the course of examination / after the completion of examination but before final stage of evaluation, any question is reported to be admittedly wrong or has wrong options/ more than four options or has all options correct or is having a major printing error in questions/options, such of the questions shall not be evaluated for declaration of results. However, where two answers to a question are correct, the candidates attempting any one of the answer of the said question will be awarded marks”

## 16. PROHIBITION/BAN ON RAGGING:

The candidates selected for the Course must bear in mind that:

Ragging is a criminal offence and UGC has framed regulations on curbing the menace of ragging in Higher Educational Institutions in order to prohibit, prevent and eliminate the scourge of ragging. Selected candidates have to follow strictly Guidelines framed by University Grants Commission (UGC) titled "Regulations in Curbing the Menace of Ragging in Higher Education Institutions, 2009" in pursuance to the Judgement of the Hon'ble Supreme Court of India dated 08-05-2009 in Civil Appeal No. 887/2009. These regulations are mandatory and all Institutions are required to take necessary steps for its implementation into including the monitoring mechanism.

### ❖ PUNISHABLE INGREDIENTS OF RAGGING:

- Abetment to ragging;
- Criminal conspiracy to rag;
- Unlawful assembly and rioting while ragging;
- Public nuisance created during ragging;
- Violation of decency and morals through ragging;
- Injury to body, causing hurt or grievous hurt;
- Wrongful restraint;
- Wrongful confinement;
- Use of criminal force;
- Assault as well as sexual offences or even unnatural offences;
- Extortion;
- Criminal trespass;
- Offences against property;
- Criminal intimidation;
- Attempts to commit any or all of above mentioned offences against victim(s);
- Physical or psychological humiliation.

### ***The guidelines to curb the menace of ragging in professional Colleges issued by the Hon'ble Supreme Court of India.***

- An annual undertaking signed by each student, whether fresher or senior and his/her parent(s) jointly stating that each of them has read the relevant instructions/regulations against ragging, as well as punishments, and that if the ward is found guilty, he/she shall be proceeded against and shall be prosecuted.
- Such an undertaking shall be furnished in English as well as vernacular language (mother tongue of the parent) at the beginning of each Academic year by every student.

- An undertaking to the similar effect should be obtained every year from each student admitted to the Hostel.
- The compliance to the above effect shall be ensured by each of the affiliating University to which the concerned Institution is affiliated and would be verified by them annually.

In order to ensure “the ragging free environment” in the Campus, each Institution shall compulsorily in their prospectus and other admission related documents, shall depict the earlier directions of the Hon’ble Apex Court and/or of the Central or UT Governments for information of the students.

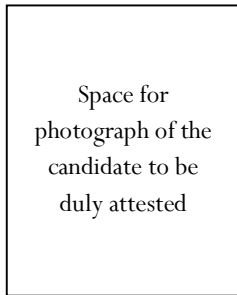

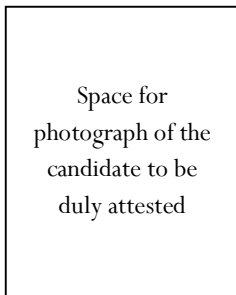
